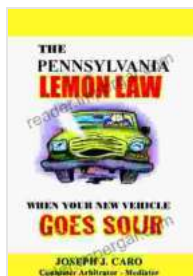


The Pennsylvania Lemon Law: When Your New Vehicle Goes Sour

The MVLL defines a lemon as a vehicle that has:

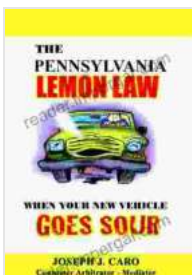
